The point of care materials include patient booklets for women experiencing an alloimmunized pregnancy and parents with a child who has hemolytic disease of the fetus and newborn (HDFN). These educational booklets have been sent to every Fetal Center in the United States and patients worldwide.

Patient Support - We provide patients throughout their journey with alloimmunization and HDFN.
