The point of care materials include patient booklets for women experiencing an alloimmunized pregnancy and parents with a child who has hemolytic disease of the fetus and newborn (HDFN). These educational booklets have been sent to every Fetal Center in the United States and patients worldwide.

Patient Support - We provide patients throughout their journey with alloimmunization and HDFN. This includes a large patient support group on Facebook with over 1,000 members worldwide where patients can connect with other women and find all the resources they need. We also mentor patients one on one by providing emotional support and answering questions they have and referring them to experienced specialists.

Advocacy and Awareness - Our advocacy and awareness program connects us with other related organizations and patients from all over the world.
